POWER OF ATTORNEY

I, William N. Priesmeyer, hereby authorize and designate each of David H. Sampsell, Amy C. Seidel, Joshua L. Colburn and Julie M. Regnier signing singly, as my true and lawful attorney-in-fact to:

(1) execute for and on my behalf, in my capacity as an officer and/or director of Digi International Inc.
